**Request for Driving Safety Course: *Take a course, pay a reduced fee.***

**You are eligible to request the Driving Safety Course Option by mail if all of the following are true:**

- ✓ You are at least 17 years of age.
- ✓ You have current liability insurance **and** a valid Texas Driver’s License.
- ✓ You have **not** taken a Driving Safety Course within the last 12 months to dispose of a citation. *(Calculated from the date of the last course completion to the date of your current citation.)*
- ✓ You do not possess a Commercial Driver’s License currently or at the time of offense.
- ✓ You are **not** charged with speeding in excess of 24 mph over the limit, nor a construction zone violation.

**To Request By Mail-**Provide the following three (3) items to Municipal Court:

1. Required Fee: Regular (*non-school*) Zone Violations - \$144 / School Zone Violations- \$169  
(Cost of course and driver record are not included and will be an additional \$40-\$55)
2. Proof of valid Texas driver’s license.
3. Proof of current insurance policy listing you as a driver.

**Mail Request-Driving Safety Course Option** (complete entire form)

I understand that this plea enters a guilty judgment, and this judgment will be removed and no conviction will appear on my record upon submitting the following: 1) a certificate of Course Completion, 2) a certified copy of my driving record as maintained by the Texas Department of Public Safety.

**I further understand that I am eligible to request a Driving Safety Course for only one violation at a time. My failure to comply with the terms of this request will result in assessment of a fine of \$100 and a possible conviction on my driving record.**
