

**RESOLUTION NO. 22-008**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTHLAKE, TEXAS, RECEIVING THE CITY SECRETARY'S CERTIFICATION OF UNOPPOSED CANDIDATES FOR THE MAY 7, 2022 GENERAL ELECTION AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Southlake, Texas ("City") is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and,

**WHEREAS**, the City of Southlake Charter provides that City Elections shall be held in accordance with the laws of the State of Texas; and

**WHEREAS**, Section 3.004(b) of the Texas Election Code provides that the governing body of a municipality shall be the authority to order a General Election for the purposes of electing members to the governing body; and

**WHEREAS**, the Council approved Resolution No. 22-004, Calling the May 7, 2022 General Election; and

**WHEREAS**, the authority responsible for having the official ballot prepared shall certify in writing that a candidate is unopposed for election to an office if, were the election held, only the votes cast for that candidate in the election for that office may be counted.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOUTHLAKE, TEXAS, THAT:**

**Section 1. Certification of the City Secretary.** As the authority responsible for having the official ballot prepared, the City Secretary hereby certifies that the following candidates are unopposed for election to office for the election that was scheduled to be held on May 7, 2022:

**Section 2. Posting of Cancelled Election.** Notice of the cancelled election shall be posted as required by Chapter 2 of the Election Code.

**Section 3. Necessary Actions.** The Mayor and the City Secretary, in consultation with the City Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Election Code in carrying out and conducting the election, whether or not expressly authorized herein.

**Section 4. Effective Date.** This resolution shall be effective upon its adoption.
